- 13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least (6) months prior to the date of expiry of the renewal.
- 14. That additional sections/higher classes should not be opened without prior permission of the competent authority.
- 15. That the recognition is accorded to society and no other society or body can open a school on their behalf.
- 16. The recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
- 17. The society shall provide the necessary material even if it costs more than the deposit amount.
- 18. Admissions should be made on the basis Record sheet issued by the Private Recognized/ZP/Govt/Aided schools only T.Cs/Certificates issued by the Secretary, DCEB as Bonafide candidate.
